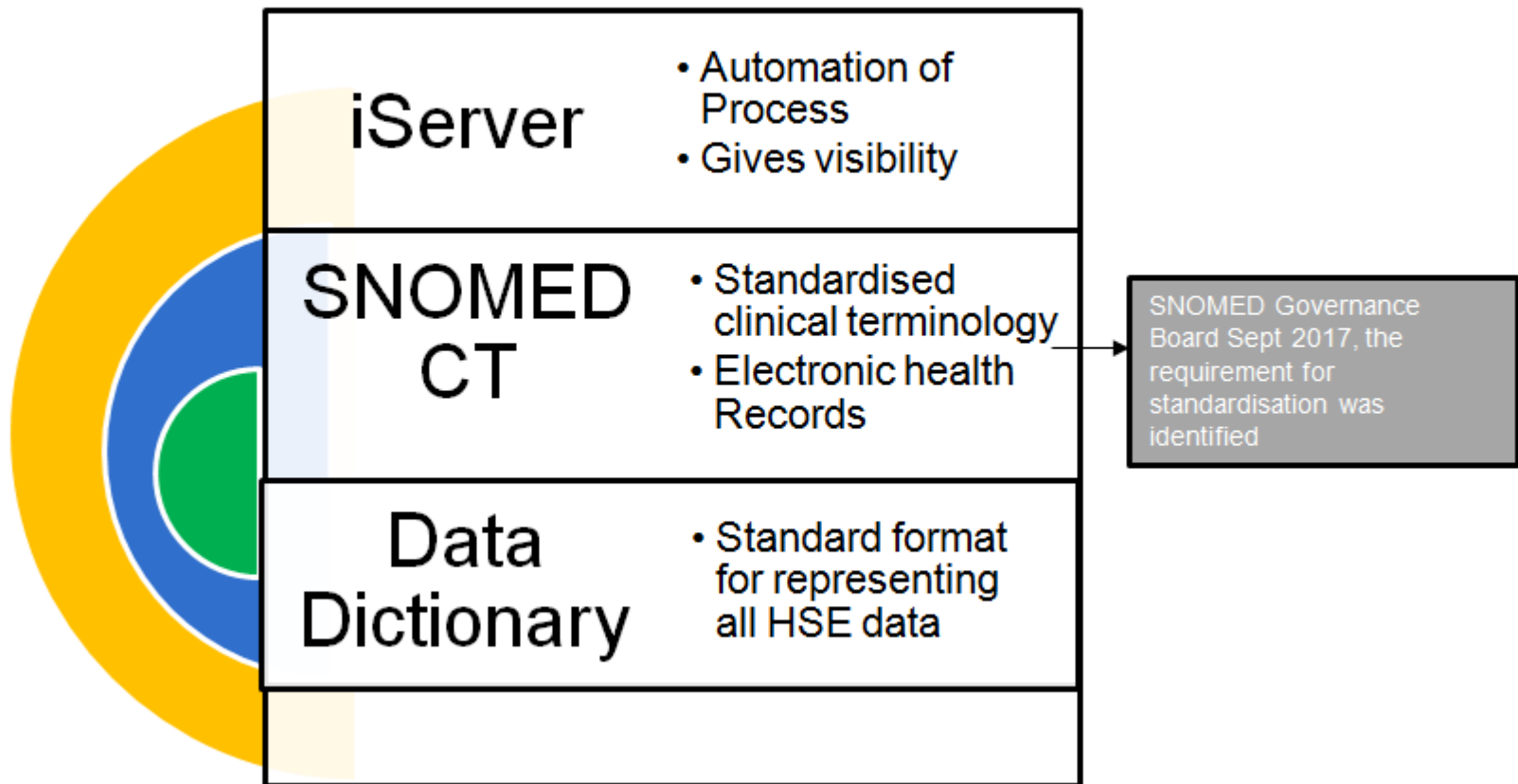

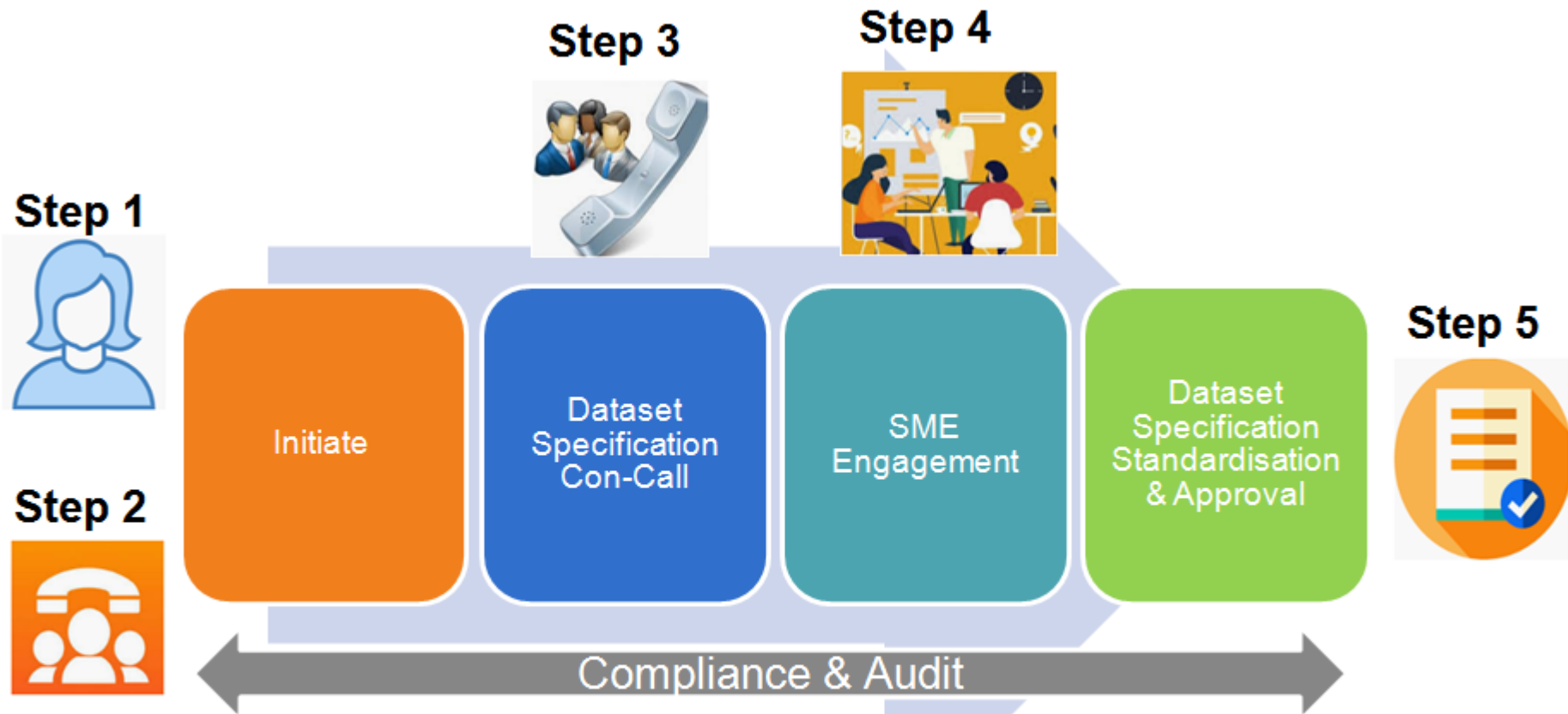

Dataset Specification Management Process

Initiate



Step 1

Dataset Requester brings Dataset Specification and with the help of the Dataset Co-ordinator completes the Dataset Specification Management Process Form



Step 2

Dataset Co-ordinator enters form on **Enterprise Architecture Portal**, conference call arranged. SME's review and share their feedback

Con-Call



Step 3

During the call each SME asks the Dataset Requestor relevant questions. SMEs agree to engage or not, as appropriate and actions from the call are noted.

Step 4

Each SME who has committed to engage with the Dataset Requestor sets a date for completing their work on this data set. SME's complete their work and close out their portion of the dataset specification.

Step 5

Dataset Requestor gets approval of the completed dataset specification from their governance body / structure. Dataset Co-ordinator records the data set as closed.
